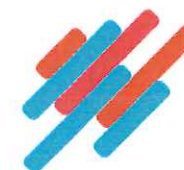


SELEP Local Enterprise Partnership: Register of Members' Interests

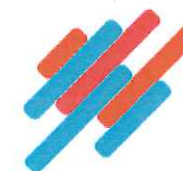
