A MESSAGE FROM THE CHAIR

In this report, we look back on some of the year's accomplishments, celebrating the region's progress and our partnership's record of delivery. This Annual Review details the progress we are making, across our portfolio of work, to move our economy forward, but I wanted to note some personal highlights.

I am delighted that the South East Creative Economy Network (SECEN) has been successful in securing £1.257m of Create Growth funding for the South East. SECEN is an open network and provides a coherent voice for the creative sector in the South East. The sector is growing at a phenomenal rate and is one of the strongest working groups in our partnership. Following a competitive process, a consortium of partners working on behalf of the South East Creative, Cultural and Digital sector has secured one of only six awards across the UK to deliver the Create Growth Programme. This will be a free programme for the creative businesses which will provide the support, the networks and the investment they need – transforming their innovative creative ideas into the leading creative businesses of the future.

In addition, we have always championed the South East Growth Hub's offer and have used ongoing feedback and insights to help shape a simpler, more coordinated business support system in the region. This year we continued to work together and responded well to changing circumstances for businesses. The group diverted funds into direct delivery of business support programmes by engaging with fantastic programmes like the Rebel Business School in response to challenging economic conditions. I am really proud of the partnership that supports our Growth Hub, and of the ingenuity, flexibility and commitment they have shown to supporting our businesses.

As always, I want to thank the formidable team at the LEP – thank you for continuing to encapsulate our values by doing the right thing for our region so we truly make a difference to the communities we serve. Thank you for working together to find collaborative solutions and to strengthen delivery. I'll always be the biggest champion of their work and ethos.

In addition to a new Chair and Deputy Chair, our board has been through small changes this year. We said goodbye to Aideen Sadler from City Fibre and Councillor Graham Butland from Braintree District Council. We welcomed Councillor Stephen George from Southend City Council and Lara Fox from Objective IT. I'd like to say a huge thank you to them all for their service and commitment to the South East

I am thankful to ALL members of the South East LEP board for the support, expertise, knowledge and guidance they have provided to me as I have made the transition into my role of SELEP Chair.

In February 2023 Government announced its decision to no longer provide funding and support to Local Enterprise Partnerships in future years and instead for the Local Authorities in our area to be responsible for strategic economic planning, ensuring a strong business voice and delivering local growth schemes. This means that by March 2024 we will need to fully integrate our activity into the work of the Upper Tier local Authorities across our area. We will work closely with our partners over the coming months to ensure a smooth transition which maintains our networks and expertise. Whilst this year ahead will bring change and new challenges, I know that together, we can build on the fantastic track record of delivery and partnership to propel our region forward.

A MESSAGE FROM THE CHIEF EXECUTIVE

The 2022-23 year has been a mixed experience for the South East. As the previous year represented a transition from impacts of the pandemic, a new set of challenges emerged for our economies; rising costs of materials, staff and particularly energy, impacting some of our industries more acutely than others.

As a partnership, we know our strengths lie in our knowledge, expertise, network and in our robust relationships. The South East LEP has a unique role as an intermediary and convenor, between organisations enabling them all to come together and find solutions to shared challenges.

One of the best ways this role manifests itself is in our working groups and SELEP's Major Projects Group (MPG) is a great example of this. The MPG was formed in 2020 and prioritised skills and employment as a substantive area of work. Alongside the MPG skills subgroup and SELEP's Skills Advisory Panel, the group commissioned a report in 2021, undertaken by Mace Group, into the collective skills needs of key major projects in the South East. We hosted a webinar this year, providing an opportunity for projects to share their updates on work to support this plan and the emerging action plan of the MPG Skills Group itself - which facilitates collaborative activity across the area, as well as from the projects directly. We heard from fantastic speakers from the Lower Thames Crossing, Ebbsfleet Garden City, Thames Freeport, Bradwell B, the Construction Industry Training Board and the UK Health Security Agency, a video of the session is available to watch here.

In addition, this year we had some exciting milestones in our capital programme, we saw the start of a project to build the first new mainline station on the Great Eastern Mainline in 100 years, at Beaulieu Station in Chelmsford. This station is part of a connected transport package that will serve the new Garden Community to the North East of the city and is expected to be open and operational early in December 2025.

We also saw the evolution of the successful 'no use empty' scheme, which expanded from Kent into South Essex with the project starting in Southend. The goal of 'No Use Empty South Essex' is to turn between 10 and 15 empty buildings back into occupation across South Essex by offering interestfree secured loans to owners and developers to support the development of alternative commercial uses or create mixed-use commercial and residential properties. This supports wider goals and further activity and investments happening in the high street which is an important part of the local economy. One of the highlights of the year for the LEP was, undoubtedly the success of our Building Garden Communities conference, which came together for the first time in person at RIBA in London. The event brings together experts, opinion formers, leaders in the field who are driving forward the Garden Communities agenda on a national scale. Watch the **post event video here**.

We were joined by Levelling- Up Minister Dehenna Davison MP for the opening of a brand new Performing Arts and Digital Creative Centre in Dartford, North Kent. The state-ofthe-art project was the largest value project in the Getting Building Fund programme and contains 2,836 sq m of educational floorspace, including a performance venue, dance studios, music performance spaces, digital design classrooms and workshops and aims to expand learning provision to meet growing student demand and contribute to the long-term growth of the creative and cultural sector, recognising the importance of the sector to the Thames Estuary economy.

We also saw three of our most significant future projects take major steps forward this year, with the submission for the Lower Thames Crossing being taken to the planning inspectorate. This is an 18 month to 2 year process to secure planning permission for a project which will have an exponential impact on the economy of our area. The new tunnel and associated road infrastructure will create new travel to work and study areas, create job opportunities and open up new spaces for development and growth. In

addition, we saw the approval of Freeport East in the north of our region, which will attract new investment to create a hotbed for trade, innovation and green energy driving growth in both the regional and national economies. The Freeport is expected to create up to 13,500 new jobs and will be boosted by £25 million in Government funding to support infrastructure enhancement. Thames Freeport has also gained approval from Government. Thames Freeport is an economic zone located in the Thames Estuary and UK's largest port – the Port of London. With 1,700 acres of development land, and unrivalled connections for access to Europe's largest consumer market and its excellent connectivity to 18 million people. A partnership between Ford, Forth Ports Limited and DP World, Thames Freeport will see over £4.6 billion in new public and private investment, and the creation of over 21,000 new jobs and many more across supply chains. Significant investment in training and skills will contribute to the 'levelling-up' of the communities and businesses in East London and South Essex.

Welcoming Sarah Dance as our new Chair and Simon Cook as Deputy Chair, was another highpoint of the year. The experience and knowledge which both bring to the partnership is unparalleled and their unwavering commitment to the relationships with SELEP's business partners, neighbouring LEPs and other key stakeholders, will stand us good stead for the year ahead.

I would like to give a note of thanks to my predecessor, Adam Bryan who admirably led our partnership during 2022/23 and for six previous years. His strong leadership and commitment to the partnership has steered us through notable achievements and accomplishments during that time.

Our track record of delivery and performance provides a firm foundation upon which our Local Authorities can build in future years. Despite the challenging fiscal environment we face, we have the right people and partnerships to achieve economic growth and future investment and, despite the very real challenges facing businesses and communities, we can be positive about the long-term future of our area.

STRATEGY UPDATE

n March 2021, the SELEP Board approved its Economic Recovery and Renewal Strategy which responded to the devastating impact of the COVID-19 pandemic on the economy, but also the implications of Brexit on supply chain issues and the labour market and the need to level up within the South East. These issues continue to have implications and more recent ones are adding further pressure, such as high inflation, tax rises, all putting additional strain on already stretched businesses and individuals. Our strategy aims to build on the unique opportunities and challenges that our area possesses and highlights four priority areas that have been identified as the unique driving forces behind the South East economy. These are:

- Business Resilience and Growth
- UK's Global Gateway
- Communities for the Future
- Coastal Catalyst

The Strategy set out a clear path and set of priorities to improve the economic performance of the south east for the future, recognising that despite the changing contexts within which we are operating, our identified strengths and opportunities remain.

Throughout 2022/23 we have continued to keep these priorities under review, considered the governance structures needed to deliver, and evolved our partnership and the relationships that exist within this, to meet the new operating context and support future transitions.

In line with Government policies for levelling up and economic growth, and expectations of LEPs within this, we also set out our three core functions - the provision of strategic planning and intelligence to provide a clear regional strategy for growth, underpinned by a robust live evidence base; communicating, collaborating and convening across our network of businesses, academia and public sector to provide a business voice and joint activity around key strategic objectives; and delivering strategic economic projects to seize opportunities to accelerate growth.

BUSINESS RESILIENCE AND GROWTH

To support BUSINESS RESILIENCE AND GROWTH we have:

- Continued to deliver Growth Hub services across the SELEP region and to evolve the Growth Hub delivery model
- Completed the COVID-19 Recovery Fund programme, including support activities for businesses, 100% business grants, 100% grants and re-boot campaigns for the Visitor Economy, skills training, and access to digital skills, kit and connectivity.
- Delivered a range of skills activities, working with the Skills Advisory Panel to deliver against the Skills Strategy and Skills Report, aligning this work to Local Skills Improvement Plans (LSIPs) and providing economic and skills data to support the LSIPs.
- Overseen future plans and priorities for the Digital Skills Partnership (DSP), which has now been rolled out to Catalyst South, led by Solent LEP, and supported by a new DSP Coordinator.
- Implemented the Strategy Network approach to strengthen two-way communication between SELEP and businesses and stakeholders. This includes a monthly newsletter circulated to almost 900 stakeholders.
- Held SELEP's Annual Conference 'South East Futures: Our Evolving Economy' in October 2023, focusing on what the changing economic conditions mean for businesses and how we are encouraging growth and investment.

To support our ambition to be the UK'S GLOBAL GATEWAY we have:

- Completed the Sector Support Fund Project -Accelerating climate-based solutions, to better understand demand for carbon sequestration projects and resources to support the emerging market.
- Produced the Town Centre footfall report in May 2022 to help understand changing patterns of footfall in SELEP's town and city centres.

LOCAL GROWTH FUND

The Local Growth Deal is a £579m capital investment programme that has supported 107 projects to deliver 25,600 jobs and 25,200 homes to date.

GETTING BUILDING FUND

The £85m Getting Building Fund has supported 40 projects that can progress quickly and that will stimulate and better integrate economies in some of the most economically-impacted and COVID-affected parts of the South East.



GROWING **PLACES** FUND

'The Growing Places Fund provides loans to unlock economic growth, create jobs and 'kick-start' building at stalled development sites. In round one, £47.459m was awarded to 13 capital infrastructure projects. Repayments from these awards has allowed funding totalling £26.604m to be allocated to a further 17 projects.

The project is the first step towards a cutting-edge innovation campus for horticulture in Kent that secures the long-term delivery of world-class research, innovation and knowledge exchange for the UK horticultural industry.

Developed by horticultural and agricultural research institution NIAB EMR in partnership with the East Malling Trust, the project creates infrastructure, services and high-tech plant growing facilities.

SELEP's investment was used to build the first of several new state-of-the-art glasshouses, as well as a new energy centre to meet the needs of the horticultural zone - known as the Green Tech Hub. The project uses advanced greenhouse designs to host high-tech imaging, robotics, precision irrigation rigs, LED lighting and CO2 systems with the purpose of advancing horticultural agronomy in the region.

Southend Central Area Transport Scheme (S-CATS) is SCAAP's delivery mechanism and supports continued growth and regeneration, strengthening and transforming Southend town centre's sub-regional role as a successful commercial and retail destination, cultural hub, educational centre of excellence, leisure and tourism attraction.

The transport scheme had three phases:

- expansion of the library car park.

Junction improvements to support the wider objective of delivering an improved and appealing gateway to the centre of Southend-on-Sea for residents and tourists; to unlock a housing site at the former South East Essex College Site, and for the

The new Construction Centre at Chelmsford College provides resources and equipment to educate and train students and apprentices to become skilled tradespeople for the construction industry.

This purpose-built, two-storey, modern facility provides cutting-edge workshops to meet the growing demand in construction, trades, heating ventilation and air conditioning engineers, plumbing and renewables. T Levels and level 4 and 5 qualifications within the industry are also offered.

Increasing the number of construction apprenticeships and industry-relevant qualifications is one of SELEP's key priorities. This will enable the local workforce to learn new skills, reskill and upskill to obtain jobs in major construction projects in the area, housing and associated infrastructure, the development of garden communities and the Lower Thames Crossing.

The high-quality, two-storey building's floorspace includes a performance venue, dance studios, music performance spaces, digital design classrooms and workshops, and a new food court and social zone serving the whole college campus.

The Meeting Point in Swanley town centre is a new and innovative work hub alongside new homes. It was achieved through the redevelopment of a prominent site, under Sevenoaks District Council ownership, which had been redundant for several years.

The project aims to bring new activity and footfall to a part of the town centre. The housing element of the scheme responded to the identified need for smaller units, especially for younger workers. The work hub element is aimed at start-ups, home workers and people who might otherwise have had to commute for work.

The new three-storey enterprise centre – The Plaza – is the focal point for the Horizon 120 Business Park, Braintree. It offers 42 private offices for small businesses, a co-working space with dedicated desks and hot desks, shared meeting and seminar rooms with roof terrace, conference and event spaces, and the Café Plaza.

The purpose-built physical and virtual environment is designed to drive collaboration, encourage idea generation and underpin problem solving.

After lying empty for 35 years and falling into dereliction, the 4,000 sqm Observer Building in Hastings is being transformed into a highly productive mixed-use building.

Leisure and retail, including a fitness centre and cafe/ bar, is spread across the lower three floors and there is a wide range of workspaces including studios, offices and open space. The project also includes 16 cappedrent flats and a public roof terrace and bar with sea, castle and town views is in the pipeline.

The 175 homes of Chatham Waterfront are spread over five buildings varying in height from six to 10 stories with ground floor commercial space. The mixed-use scheme is key to revitalising the area and also includes co-working spaces, places to eat and drink, shops, new public realm and marketspace.

Sustainable transport has received a boost through the replacement of the Sun Pier Pontoon to provide a river taxi service.

Improved flood defences, including the integrated river wall, have significantly reduced flood risk.

he SELEP Growth Hub is part of the Governmentfunded network of 38 Hubs, with one in each LEP area. It is a fully funded, impartial service for businesses and entrepreneurs across the South East area, helping business leaders achieve their growth ambitions.

The SELEP Growth Hub operates under the umbrella of South East Business Hub with three very distinctive delivery arms: Business Essex, Southend and Thurrock (BEST) Growth Hub, Kent & Medway Growth Hub and Business East Sussex Growth Hub.

In 2022-23, Growth Hub funding was reduced by 50% from previous years so the delivery model was significantly re-designed and streamlined, at pace, to ensure no break in service. It was recognised – following growth hubs' engagement with their clients - that businesses were tackling combined crises including cost of living, cost of doing business and rising energy costs. Proactive engagement helped growth hubs to actively seek out businesses requiring support.

As well as business engagement offering general advice, signposting and referrals to relevant schemes, targeted support was also provided to improve business resilience. This included specialist advisors for export support, investment for growth wraparound support, trading standards advice and net zero audits, as well as 1:1 support to grow provided by Digital Islands, and a Rebel business school programme for start-ups.

The SELEP Growth Hub has worked closely with Hertfordshire and London Growth Hubs, as the South East Cluster, to share good practice and identify efficient practices. Knowledge sharing and information sessions were run across the cluster, building relationships with national and regional providers such as Innovate UK Edge, British Business Bank, the Institute of Chartered Accountants in England and Wales, and local library services. This programme provided upskilling within the growth hubs themselves and across their network of providers, further strengthening the network and the business support ecosystem.

FINANCIAL SUMMARY

ssex County Council (ECC) is the Accountable Body for SELEP; in this capacity it manages all financial transactions on behalf of SELEP, including receipt and payments of grants, overseeing contract management with suppliers and ensures that the Partnership has sufficient cash flow.

The SELEP Accountability Board agrees an annual operational spend each year which covers the running costs of the LEP's Executive Team and Boards, including staff salaries, office expenses, publicity and marketing, and professional fees.

The operational spend is funded through core funding from the DLUHC, match funding contributions from partners and interest received on cash balances invested by the Accountable Body on behalf of SELEP. Any surplus or deficit held at the end of the financial year is managed through the operational reserve.

ECC administers the capital and revenue grants that have been received from Government, on behalf of SELEP, in accordance with the agreed decision making and governance arrangements of the LEP.
